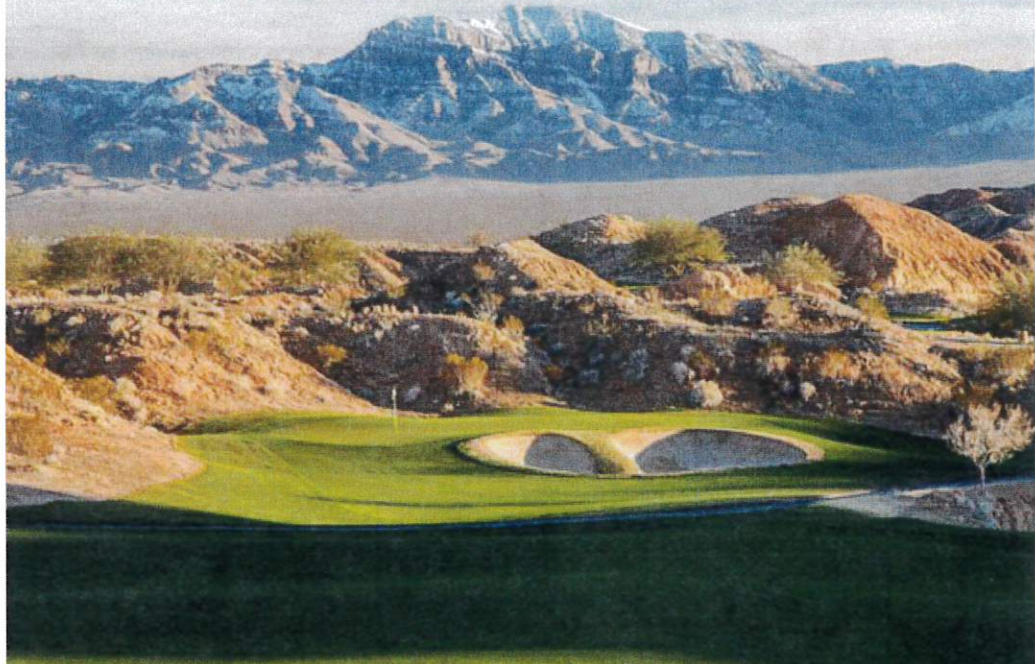

You have 48 hours to cancel your tee times or adjust your player count; if you do not, your credit card on file may be charged.

Rates will only be honored when specified booking windows are followed, any tee times booked outside of stated windows will be considered booked at the applicable rate.

All pass holders must book a tee time and check in to the Golf Shop prior to teeing off. A pass at this facility does not entitle you, your guests, or family members regardless of age to play golf without a tee time or checking into the golf shop prior to teeing off.

If you are not going to show for a reserved tee time you are asked to call and cancel the tee time. If your group is going to have fewer players than it was booked for you are asked to call and adjust the number of players.

Participation in any Conestoga program does not provide membership, ownership, or control of club decision making in any way.

Passes/programs may not be sold or transferred and may be modified by management without notice at any time.

Conestoga Golf Club reserves the right to offer other discounted rates and specials throughout the year. No collected fees will be refunded at any time throughout the year due to any special offers.

Outside tournament play, scheduled activities and events are booked by management more than 60 days in advance.

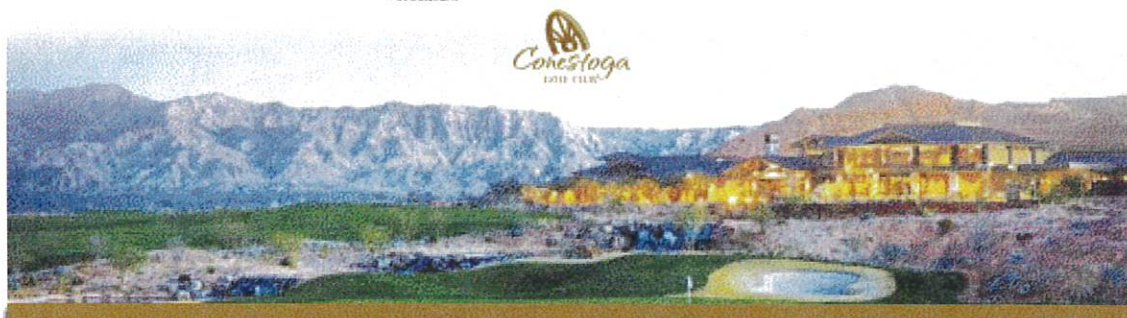

367-Day SCM Booking Agreement

Terms & Conditions

The 367-Day SCM Booking Program is a booking window which is available to all Sun City Residents. It opens 367 days out and closes when the appropriate passholder (60 days) or resident (58 days) booking windows open. 367-Day SCM booking rates apply to all Residents, regardless of any pass held, until the passholder/resident booking windows open.

TERMS & CONDITIONS:

Booking Policy: 367-Day SCM booking rates are only available to properly registered Sun City Residents. Proof of residency may be required at booking. Only 1 tee time per household (foursome or less) may be booked each day. A 50% deposit is due and payable at the time of booking. The remaining 50% is due and payable upon check-in. Any resale of 367-Day SCM tee times is strictly prohibited and may result in the suspension or loss of 367-Day SCM Booking privileges.

Transfer Policy: Should the need/desire arise, the Sun City Resident holding a 367-Day SCM tee time may transfer it to another properly registered Sun City Resident following review/approval of Golf Course management. Any remaining balance will be due and payable upon check-in. Transfer to a non-resident is not allowed.

Check-In / Starting: Normal check-in procedures apply. A 367-Day SCM tee time does not entitle you to play golf without checking into the golf shop prior to teeing off. If, on the day of play, the course is operating with a shotgun start, 367-Day SCM players will be assigned a starting tee in the same manner as other golfers.

Cancellation Policy: Your deposit is fully refundable if your 367-Day SCM tee time is cancelled 90-days or more in advance. If you reduce the number of players in your group more than 90 days in advance that portion of your deposit is fully refundable (or may be applied to your remaining balance at your option). If you cancel or modify your tee time less than 90-days in advance the full amount of your deposit will be retained by the golf course. If you book your tee time fewer than 90-days in advance, but before either the passholder or resident booking windows open, your deposit is non-refundable.

100 Day Follow Up: Approximately 100 days before your scheduled 367-Day SCM tee time, you will receive an email notification reminding you that the close of the refundable cancellation window is approaching. No other notice will be provided.

No Show Policy: If the homeowner or any of the members of his/her group fail to show with less than 48-hours' notice, the homeowner holding the reservation may be charged any remaining green fees. Failure to pay no-show fees may result in the suspension or loss of 367-Day SCM Booking privileges.

Conestoga Golf Carts: Conestoga Golf carts are not allowed off Conestoga property or into the parking lot at any time. You must have a valid driver's license to operate a cart, and you are responsible for any damage done to a cart by you or your guests. All players agree to two carts per foursome.

Outside Food/Beverages: No guests of Conestoga, including passholders, are permitted to bring outside food or beverages onto the property. Any guest, including passholders, not abiding by these rules is subject to pass suspension and/or revocation.

Decorum: Physical or verbal abuse toward any other guests or staff will not be tolerated. Any person involved in a confrontation will be asked to leave the property regardless of perception of fault and may lose the privilege to use the facility.

Pricing/Other Programs: Pricing, availability, as well as terms and conditions are subject to change. Conestoga Golf Club reserves the right to offer other discounted rates and specials throughout the year. The preferential rates offered by these programs may not be used in conjunction with any other discount, promotion, pass or program. No collected fees will be refunded at any time throughout the year due to any special offers.
